APPENDIX 1: Municipal Residential Drinking Water Systems' 2009-10 Inspection Ratings and Drinking Water Quality Results (Percentage of Tests Meeting Standards)

Pursuant to **O. Reg. 188/07** (Licensing of Municipal Drinking Water Systems), many of the ministry's municipal drinking water system owners have requested that the ministry adopt a consistent naming convention with the suggestion that their system name changes be identified on their new municipal licences/permits.

The change to the system licence/permit name will better reflect the legislative definition of "drinking water system" and will provide clarity with respect to public reporting. As a result of this request and the issuance of municipal licences/permits to system owners, the names of systems will be changed starting with this report. This list reflects naming as of March 31, 2010.
